What are cookies?

Cookies are short text files that a website sends to your browser. They allow the website to record information about your visit so that we can display the website to you correctly. Thanks to these settings, websites visits can be easier and more user-friendly for you. Your cookies are stored only with your consent. You can change your cookie preferences at any time.

How to refuse, delete or set the use of cookies

The use of cookies can be set using your internet browser. Most browsers automatically accept cookies by default. You can use your web browser to reject cookies, set the use of only certain cookies or delete them completely. Disabling cookies may affect the functionality of this and many other websites you visit. Disabling cookies will usually result in disabling certain features and properties of this site. For more information, please use the help of the web browser you are using.

What cookies do we use?

We use essential (technical) and analytics cookies on our website. According to the type, the table below lists the purposes of personal data processing (hereinafter referred to as „PD“).

User, a person who has visited the website	Essential (technical) cookies – storing or accessing information on the device and ensuring proper functionality, ensuring the protection and security of our website, proper use of the website. User, a person who has visited the website	Analytics cookies – allow DEKONTA Slovensko to recognize and count the number of users and obtain information about how the website is used (e.g. which pages the user opens most often and whether the user receives error messages from some sites). This helps to improve the way the website works, for example by allowing the user to easily find what they are looking for.	The consent of the person concerned	Listed in the Cookies List table	Entities to which are data provided based on the law
